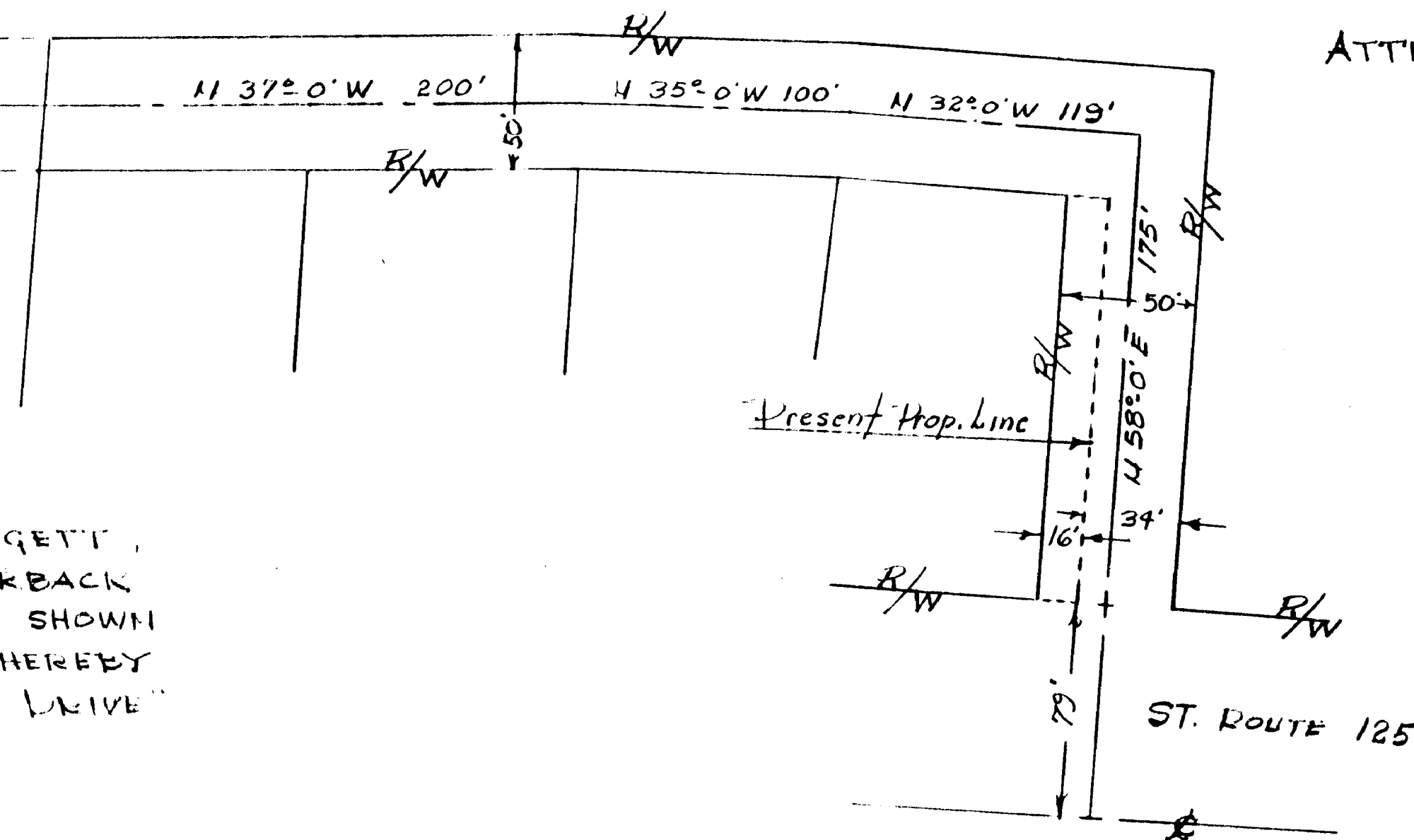


**DISCRPTION:**
