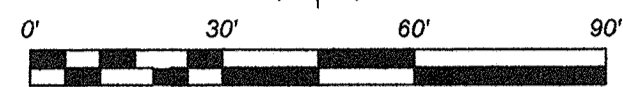
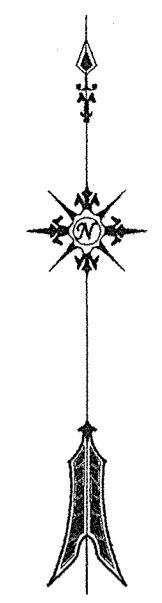


NOTE:

The intention of this plat is to reaffirm the layout and dimensions of the vacation of an alley in the Village of Sardinia, passed April 1958, by Ordinance Book NO. 2, Page 264, and to become a document of record in Office of the Recorder of Brown County, Ohio



Bearings are magnetic and based upon the record bearing (N07°00'00"E), being the east line of Main Street.

ORDINANCE No. 162.

AN ORDINANCE TO VACATE AN UNNAMED ALLEY TWELVE (12) FEET IN WIDTH, EXTENDING EAST FROM MAIN STREET ALONG IN-LOT NO. THREE (3) IN SAID VILLAGE OF SARDINIA, BROWN COUNTY, OHIO.

WHEREAS, on the eleventh day of September, 1957, a petition by the owners of lots in the immediate vicinity of an unnamed alley along in-lot no. three (3) which alley is twelve (12) feet wide and extending east from Main Street, a distance of one hundred thirty one (131) feet, was duly presented to Council praying that said unnamed alley between the points named be vacated; and notice of the pendency and prayer of said petition has been given, as required by law, by publication in The News Democrat, a news paper of general circulation in the Corporation, for six consecutive weeks, ending the thirtieth day of April 1958; and,

WHEREAS, Council, upon hearing, is satisfied that there is a good cause for such vacation, as prayed for; and that it will not be detrimental to the general interest and ought to be made; new, therefore, be it ordained by the Council of the Village of Sardinia, Brown County, State of Ohio:

SECTION I

That an unnamed alley twelve (12) feet wide along In-lot no three (3) and extending east from Main Street for a distance of one hundred thirty one (131) feet be, and the same is, hereby vacated.


SECTION II

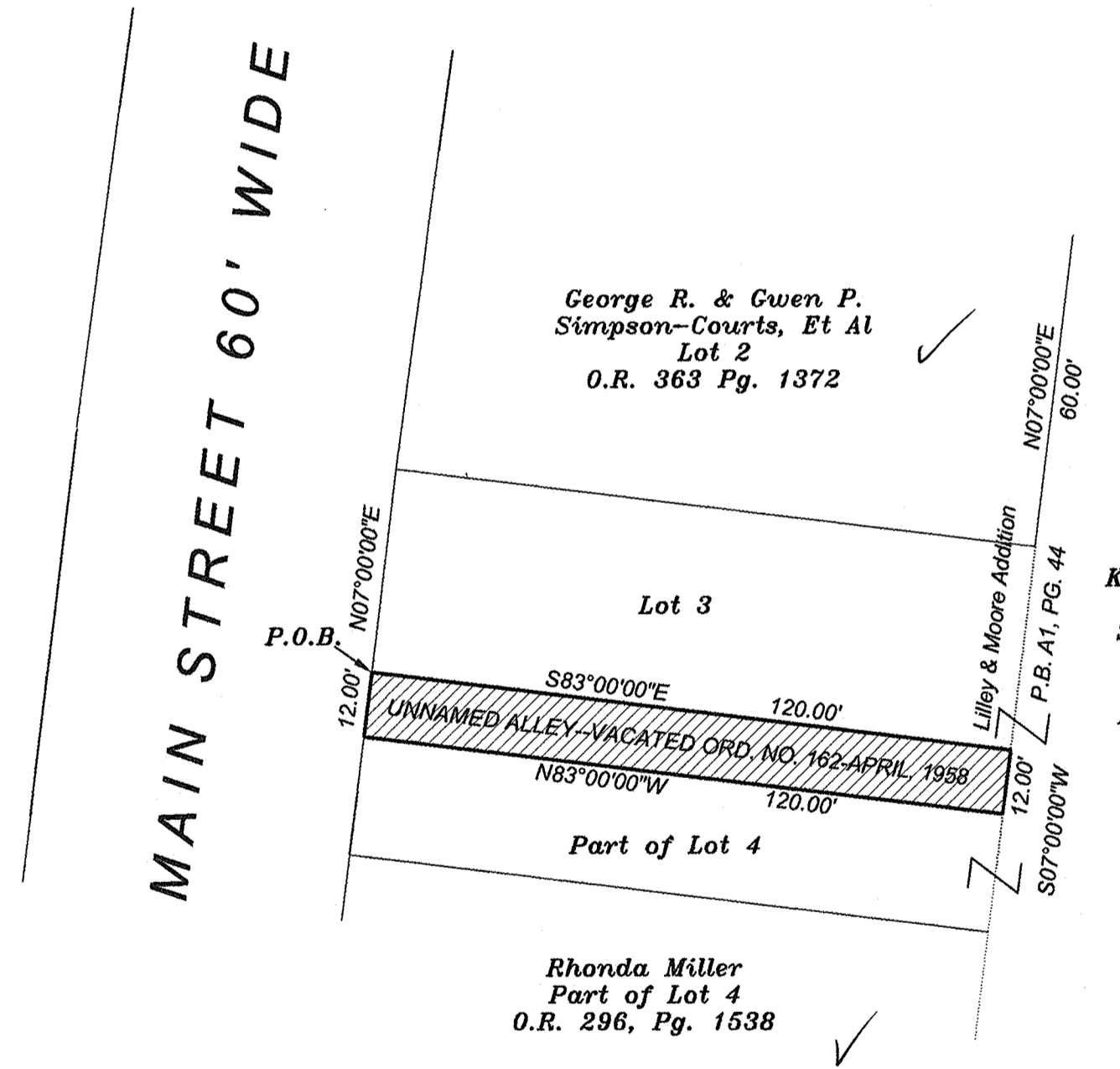
That this Ordinance be and remain in force from and after the earliest period allowed by law.


 Area to be Vacated


